

# 2008-2009 Verification Worksheet



Your application was selected by the U.S. Dept. of Education for review in a process called "**verification**." In this process, Nyack College is required by law to compare the information from your FAFSA application with the information provided on this form and with signed copies of your 2007 Federal 1040 income tax returns (and your spouse's if you are married, and parents' if you are considered dependent for federal aid purposes). If there are differences between your application and the documents you've submitted, corrections may need to be made.

## WHAT DO I DO WITH THIS FORM?

1. Collect your and your parents' financial documents (signed 2007 Federal 1040 income tax forms, W-2, etc.) If you do not have a copy of your tax return, you may contact the IRS at 1-800-829-1040.
2. Complete and sign all information on this worksheet.
3. Submit the completed worksheet, tax forms, and any other documents to the office of Student Financial Services.
4. We will compare the information on these documents to the FAFSA. We will inform you if there is any other information we require.
